

**CAMPING PASSES FOR:
WOOD AVENUE LOT - 4-H, BEEF, DAIRY,
GOAT, SHEEP, SWINE.**

A form will be needed for each unit. Camping pass must be **purchased** by entry closing dates listed below and in each division. Camping forms must accompany livestock / 4-H entry forms.

Camping units must arrive and be in place by Wednesday September 1st by 8 a.m. and will not be permitted to leave compound area before Sunday September 5 at 8 p.m.

The full 5 day pass (**\$25.00**) must be purchased. Camping units will have a designated numbered space assigned to them. Vehicles will need to purchase a parking pass to park in designated **PARKING ONLY** area.

Prepaying for overnight parking will allow the entry office to have all paperwork needed available at the Show Office upon arrival at the Fair. RV's not paid for in advance will not be permitted in the Beef, Dairy, Goat, Sheep, Swine, 4-H camping Areas.

Please report to the Show Office upon arrival at the IPE grounds to receive instruction and to receive your parking pass. All passes must be affixed to vehicle in a visible location. Pass is issued for a specific vehicle only. If pass is transferred from vehicle, removed from windshield/visor or expired, the vehicle will be towed and or impounded at owner expense. A "camping unit" is considered to be the vehicle that people are sleeping in. Vehicles that do not fit this definition are not permitted in the overnight parking area.

Please park as directed. Vehicles not complying with the IPE parking staff directions or occupying an excess of space beyond vehicle specifications listed below will be towed at the owner's expense.

Please return your completed form by entry closing dates: 4-H July 17th, Beef, Dairy, Goat, Swine, & Sheep July 23, 2010 Spots in this lot are assigned on a first applied, first assigned basis.
